Invitation

The Comstock Center Downtown Development Authority (DDA) is inviting Contractors to be part of implementing the *Beautify Comstock Center* initiative by providing maintenance of new plantings in five gateways and placing and maintaining 30 planters around Comstock Center in the 2022 growing season per an established plan.

Scope of Work

The DDA is seeking a proposal to place and maintain 30 planters around the Comstock Center area *AND* to maintain five gateways as described herein for the 2022 growing season.

The DDA is expecting the Contractor to maintain landscaping following installation by a separate contractor at 5 gateway locations and pick up, place, and maintain planters filled by River Street Flowerland as generally shown on the attached map.

Planters

- There are 30 planters. The planters measure 36" in diameter and 23" in height. A spec sheet is attached.
- The planters will be filled by River Street Flowerland. The Contractor will pick them up from River Street Flowerland (1300 River Street).
- The planters will be ready for placement the first week of June. The planters may be available the week prior to Memorial Day depending upon River Street Flowerland's schedule. The Director will keep the Contractor appraised of when the planters will be ready for placement.
- The DDA Director will provide a placement plan for the planters.
- Planters placed on an unpaved surface require the placement of a concrete base underneath so that they are level; the concrete bases have already been secured.
- The planters are to be thoroughly watered every 3 days unless the weather is hot and windy then in such periods the planters should be watered every other day. The planters do have drain holes.
- Plants must be dead headed as needed; plants are to be trimmed as necessary to control excess growth of one or more plants in a planter.
- Planters must be fertilized mid-summer with a booster. Contractor is to provide the brand name of the fertilizer for approval by the Director before use.
- The planters are to be emptied and relocated to the Township maintenance building property no sooner than October 15 and no later than October 31, 2022.

Gateways

- The gateway signs will be completed by the sign contractor no later than June 1, 2022. Construction of each gateway will commence by a separate contractor as soon as the sign has been placed and will be completed no later than June 30, 2022.
- The gateways are unlikely to be completed simultaneously, however, maintenance of each gateway is to begin within three (3) days following its completion.
- The gateways will not be served with irrigation or power.
- The gateways are to be thoroughly watered every 3 days unless the weather is hot and windy then in such periods the gateway plants should be watered thoroughly every other day.
- The gateways are to be weeded and plants dead headed as necessary.
- Perennials are to be cut-back at the end of the growing season but not sooner than October 15 or later than October 31.
- The Director is able to share the name and contact information of the landscaping and sign contractors upon award of the contract for coordination purposes.

Insurance

The contractor is required to provide and maintain at all times during the project the following insurance. If any parts of the contract are sublet, insurance shall be provided by the contractor on behalf of the subcontractors to cover their operations. The insurance shall be contracted with a vendor licensed to do business in the State of Michigan and shall be subject to approval by the DDA. Certified copies, setting forth the limits and coverage, shall be furnished to the DDA Director before commencing with any work. The policy shall contain endorsements stating that at least a 10-day notice will be given to the DDA Director prior to termination or any change in the policy and shall describe the project and provide coverage for the following terms:

- A. Comprehensive General Liability Insurance with limits of liability not less than \$1,000,000 per occurrence and/or aggregate combined single limit with the DDA and Township listed as and additional insured. Professional liability insurance coverage in the amount of \$1,000,000 minimum.
- B. Motor Vehicle Liability Insurance, including applicable no-fault coverage, combined single limit bodily injury and property damage shall be maintained during the life of the contract. Coverage shall include all owned vehicles, all non-owned vehicles, and all hired vehicles.
- C. Workers Compensation Insurance, including Employers' Liability Coverage in accordance with all applicable statutes of the State of Michigan.
- D. If any of the insurance is cancelled, the contractor shall cease operations and shall not resume until new insurance is obtained.

Supplemental Information

The DDA Director is willing to meet interested contractors to view the planters in storage.

The DDA reserves the right to revise contents of the proposal and to negotiate all aspects of this proposal and any future agreement with the selected contractor. The DDA has the right to waive any irregularities in submitted proposals or to reject any or all proposals.

The DDA has the right to disclose information contained in the submittals. The DDA further reserves the right to photocopy, circulate or otherwise distribute any material submitted in response to the Request for Proposals. Original materials which the contractor may wish returned shall be clearly marked to be returned.

The selection of the successful contractor shall be made without regard to actual or perceived race, color, religion, political affiliation, veteran status, national origin, sex, age, height, weight, marital status, physical or mental disability, family status, sexual orientation, or gender identity.

Comstock Township and the DDA are an Equal Opportunity Employer.

The selected contractor will be required to enter into a contract agreement for this project.

Timeframe and Budget

The maintenance of individual gateways must begin within three days of completion.

The planters are to be placed within a week of them being ready – likely the first week of June but possibly the last week of May.

The maintenance of planters and gateways must continue through October 2022.

Proposals should include an overall project budget for maintenance of the gateways and planters for the entire growing season as described herein.

Proposals should include client references.


Detail View

River Street & Comstock Ave Detail View








SITE PLAN -KING HWY & SOUTH WENKE PARK


