Due to the February 22nd ice storm, we are waiving the \$10 per cubic yard brush drop-off fee at the Comstock Charter Township Transfer Station. You can stop by the transfer station at 6604 East Main Street on the following dates and times:

- Thursday, March 2nd from 11:00 a.m. to 4:00 p.m.
- Saturday, March 4th from 9:00 a.m. to 4:00 p.m.

We are ONLY waiving the brush drop-off fee for Comstock Charter Township Residents and it ONLY applies to brush, not logs, trees, or other debris caused by the winter storm. We're gearing up for the May 2nd election. If you're on the permanent Absent Voter Application list, yours should be arriving in the mail soon. Check your voter id card to learn where your polling location is if you plan to vote in person. There are more details on the May election on page 7.

If the lot owner dies and plots are unassigned, a will or a probate court order would be required by law to allow heirs to use remaining plots. The 2022 property tax year has concluded. Any amounts still owing must now be paid to the Kalamazoo County Treasurer.

The assessor has mailed out the 2023 assessment notices and they should be hitting your mailbox soon. If you want to appeal your values, please see the notice for March Board of Review information including dates and times.

Water and sewer special assessment bills will be sent out in April and will be due by August 1. Any amounts not paid by November 1 will be added to the winter tax bill.

Hoarding and Fire: Reducing the Risk

Do you have a person in your life who may be a hoarder? Hoarding is a condition where a person has persistent difficulty discarding personal possessions. The large amount of possessions fill the home and prevent the normal use of the space. Living space becomes cluttered. It may be unusable. Hoarding brings distress and emotional health concerns.

Why Hoarding Increases Fire Risk

- Cooking is unsafe if flammable items are close to the stove or oven.
- Heating units may be too close to things that can burn. They might also be placed on unstable surfaces. If a heater tips over into a pile, it can cause a fire.
- Electrical wiring may be old or worn from the weight of piles. Pests could chew on wires. Damaged wires can start fires.
- Open flames from smoking materials or candles in a home with excess clutter are very dangerous.
- Blocked pathways and exits may hinder escape from a fire.

How Hoarding Impacts First Responders

- Hoarding puts first responders in harm's way.
- Firefighters cannot move swiftly through a home filled with clutter.
- Responders can be trapped in a home when exits are blocked. They can be injured by objects falling from piles.
- The weight of the stored items, especially if water is added to put out a fire, can lead to building collapse.
- Fighting fires is very risky in a hoarding home. It is hard to enter the home to provide medical care. The clutter impedes the search and rescue of people and pets.

How Can You Help Reduce the Risk of Fire injury

- ✓ When talking to a person who hoards, focus on safety rather than the clutter. Be empathetic. Match the person's language. If they call it hoarding, then you can call it hoarding.
- Help the residents make a home safety and escape plan. Stress the importance of clear pathways and exits. Practice the plan often. Exit routes may change as new items are brought into the home.
- Install working smoke alarms in the home. Test them at least once a month.
- Reach out to community resources. Talk to members of the fire department to alert them of your concerns. They may be able to connect you with members of a hoarding task force for additional help. Reducing the Risk Comstock Fire & Rescue





Election Update

There will be a May 2nd election. If you're on the permanent absent voter list, you should receive your application soon.

We're waiting on more details and guidance from the State of Michigan on the implementation of the voter-approved Proposal 2022-2 that was on the ballot in November of 2022. Many of the elements will be put in place in 2024.

The changes you'll see this election will primarily be with absentee voting. The first thing is you'll have the option to choose "Permanent Ballot", which will be on the application. This will allow you to receive a ballot each election without submitting an application first.

The second thing you'll see is prepaid postage on the application as well as on the return ballot envelope. We will also continue to have a dropbox under video surveillance in front of the Township Offices.

Voting processes at in-person polling places will remain the same at this time, nine days of early voting will not go into effect until 2024.

Comstock Township OMPUNIT. Spring Curbside Pickup 2023



Dates and Policies

- Spring Curbside Pickup begins <u>May 8th</u>.
- Clean-up is for residents that live within Comstock Township's limits only.
- · All items must be put out on May 6th or May 7th. Any items not put out by then will not be picked up.
- We hope pickup will be completed within 2 weeks, but pickup will go until crews have reached each street once.
- Crews WILL NOT return to areas for items placed after specified dates listed.

The following items are accepted

- · Household doors and windows, furniture, carpeting, toys, miscellaneous rubbish/junk, and packaging
- Limit 4 cubic yards
- Glass should be in a cardboard box or other sturdy container and taped shut
- Mattresses/Box Springs MUST be wrapped in plastic
- Nothing will be accepted that 2 people cannot safely pick up and place into a truck
- No plastic bags
- Loose items must be in boxes

The following items will NOT be accepted

- Hot Tubs
- Boats that have been cut up
- Concrete, Blocks, Bricks
- Freon appliances such as refrigerators
- Freezers and dehumidifiers
- Electronics including computers, printers, monitors, and accessories
- Televisions
- Auto parts or engines
- Tires

- Batteries
- Florescent light bulbs
- Chemicals, paints, solvents, pesticides, herbicides
- Other household hazardous waste
- Iron or steel or cast-iron bathtubs
- Stumps, yard debris, brush
- Medical waste
- Oil, Gasolines or antifreeze

Consumers Concrete and the Kalamazoo County Hazardous Waste Center can handle disposal of some of these items. Contact them for more of that information.
