Many folks have been reaching out and asking about curbside pickup. Pickup begins Monday, May 8. Please bring your trash to the curb on either Saturday, May 6, or Sunday, May 7.

Our crews cannot accept everything. Household doors and windows, furniture, carpeting, toys, miscellaneous rubbish/junk, and packaging are all accepted. Glass is accepted but MUST be a cardboard box or another sturdy container and taped shut. Mattresses are allowed, but MUST be wrapped in plastic. We have a flyer on page 10 that lists what is accepted and isn't accepted by crews at curbside pickup. As a general rule- anything 2 people cannot SAFELY pick up and put into a truck is not accepted.

Please understand that not following these rules will result in your trash not being removed from you curb, we must prioritize the safety of our crews first and foremost.

On the ballot for the May 2 election is a countywide KRESA millage renewal. Precinct 4, which is located in Gull Lake Community Schools district, also has a millage on the ballot.

If you're on the permanent Absent Voter (AV) list, you should have received your application and possibly your ballot by now. You may have noticed an option to select "I want to vote absentee in all future elections. Automatically send me an absent voter ballot for every election". This is a result of the voter-approved Proposal 2 that was on the November 2022 ballot. This means that you will no longer need to submit an application to receive an absentee ballot, you will automatically be sent a ballot for all future elections. If you do not select this, for now at least, you will still need to submit an application to receive a ballot. Another piece of Proposal 2 you'll see this election is return postage on both the application and ballot envelopes. You can mail your ballot in or use our dropbox outside of Township Hall.

Please note also that this is the first election where we will not modem results to the County as we close down our tabulators at the end of election night. The results will be hand delivered which means there will be a delay in results being posted on the County's website. We will post the results tapes from our precincts on the door to Township Hall on election night as we receive them.

Open Burn Permits

Open Burning Permits are required for any type of outdoor burning that is not contained in an approved container or barrel.

An Open Burn Permit is NOT required for the following:

- · Burning in an approved burn barrel or waste burner
- Recreational fire (as defined under Recreational Fires)

Applying for Open Burn Permits: Permits may be obtained by utilizing the Comstock Township Burn Permit Application System (BurnPAS[™]) by visiting our website at <u>www.comstockfire.com</u> (click on the Burn Permits tab at the top), or alternatively you may call or stop into any of our fire stations. Permits are only valid for the day the permit is issued. A new permit must be requested for each day that you wish to burn.

Permits are based on several requirements including favorable weather conditions and lot size. You will need to acknowledge the burning ordinance before a permit is issued. If your property address does not meet the lot size requirements according to the ordinance your permit will be denied. As a reminder you can only burn from sunrise to sunset and burning is restricted to leaves, brush, tree limbs, stumps, and lumber. Burning garbage, paper products, building material other than lumber, plastic, rubber products, and grass clippings are specifically prohibited. The Transfer Station is free to take leaves for township residents.

Recreational Fires: Recreational fires do not require a burn permit as long as the fire is contained in a fire or barbecue pit,

- Not to exceed three feet in diameter and not to exceed two feet in height.
- All recreational fires must be at least 25 feet from any building, property line, or other combustible material.
- Waste matter which causes a dense smoke or odor to go onto adjacent property may not be burned, under permit or otherwise.

Burning Barrels and Waste Burners: No burn permit is required for burning in a burn barrel or waste burner if it complies with the following rules:

- Burning barrels and waste burners are to be constructed of a non-combustible metal or masonry container, not to exceed a capacity of 55 gallons.
- Containers must be in good condition with holes or openings on the sides not to exceed ½ square inch. All containers must have a cover or spark arrester on top with holes no larger than ½ square inch.
- Burning barrels and waste burners must be kept as least 15 feet from any building, public roadway, property line or other combustible materials.
- Only paper products, leaves, brush, tree limbs, stumps or lumber may be burned in these containers.
- Burning of grass clippings, garbage, building materials other than lumber, plastic and rubber products are specifically prohibited.

In addition, the Fire Chief and/or his/her authorized representative may require the fire to be discontinued if he/she determines that the smoke from the fire is reasonably offensive to persons on surrounding property or that the fire constitutes a hazardous condition.

Friendly reminder to all residents about grass mowing season quickly approaching.

All properties located in the Charter Township of Comstock will be subject to enforcement of the "Comstock Township Noxious Weed and Uncontrolled Plant Growth Ordinance" (Ordinance No. 486 Adopted 2-20-2017) starting on May 1st 2023.

The purpose of this Ordinance is to maintain the character with the development of and landscaping in the neighborhood by removing noxious weeds and any other uncontrolled plant growth, weeds or grass exceeding eight (8) inches in height. It is the responsibility of all owners to prevent and/or eliminate noxious weeds before they reach a seed-bearing stage of growth, and/or to cut weeds and tall grass in yards on a routine basis.

Failure to comply with this notice will result in the Township taking action by contracting for the services necessary to remedy the violating condition. All expenses incurred to bring this property into compliance shall be paid by the owner(s). A lien shall be placed against the property, and if not paid, the amount shall be assessed as a special tax against such land on the next assessment roll and will be collected in the next tax cycle.

Cemetery Rules and Regulations Page 10

Cemetery Rules & Regulations

No materials of any sort shall be established or maintained to define a cemetery lot.



No flowers, shrubs, trees or vegetation of any type shall be planted within the cemetery.

All refuse of any kind including driedup flowers, wreaths, balloons or statues must be removed from the cemetery within 10 days after burial.



Holiday and seasonal decor are permitted two weeks prior to and two weeks following the

holidays. Holidays include New Year's Day, Easter, Mother's Day, Memorial Day, Father's Day, Independence Day, Labor Day, Halloween, Veterans Day, Thanksgiving and Christmas/Kwanzaa or Hanukah.

One container to hold cut flowers, artificial flowers or any other season specific item is permitted. The items shall be placed on the side of the monument on a patio stone. In addition, one shepherd's hook for a hanging basket is allowed, placed flush to the side of the monument.

> Artificial flowers, in cones or placed directly in the ground, are not allowed.

The Township reserves the right to remove or dispose of any items, tree, plant or shrub planted in violation of the ordinance.
