The expected elections in 2024 are the February 27th Presidential Primary Election, the August 6th Primary Election, and the November 5th General Election. There is also a possibility of a May 7th Special Election if a local proposal is submitted

Proposal 2022-2 passed by Michigan voters in November of 2022. Some of what this proposal does is give all Michigan voters a right to vote in-person at an early voting site. Early voting starts the 2nd Saturday before the election and ends the Sunday before. This means early voting starts on February 17th for the Presidential Primary. Early voting hours are 9:00 am - 5:00pm. You can find a list of locations online and on page 4.

You also have the option to absentee vote or vote in-person on election day at your local polling place.

Winter property tax season is in full swing. If you expect to receive a property tax bill and it has not arrived, please contact the Township Treasurer to make sure your correct address is on file. Property tax payments can be made by mail; in-person at the Township office; by using our drop box located at the east end of the parking lot; or online at www.comstockmi.gov. We accept cash, check, money order, electronic check (\$3 fee), and major credit cards (3% fee). When paying online, we also accept PayPal, Venmo, Google Pay, and Apple Pay (3% fee for each). To avoid penalty, payment must be received by 5:00 p.m. on February 14, 2024. Postmarks will be accepted if payment is received by February 21. The Township is not responsible for lost mail or mail delays.

Need a Kalamazoo County Dog License? We will be selling them through February 28 at the Comstock Township office. Starting March 1, licenses must be purchased at Kalamazoo County Animal Services.



Promotions

Congratulations to Curtis Crabtree, Jesse Ogden, and Michael Meulman on their well-deserved promotions to Lieutenant. The Comstock Township Board officially approved these promotions on December 18, 2023.

Curtis Crabtree, a dedicated member of Comstock Fire & Rescue since 2015, now serves as Lieutenant at Station 9-2. Having become a full-time firefighter in 2020, Lt. Crabtree's contributions are crucial. As the Infectious Control Officer and a certified Fire Inspector, he helps ensure the department's safety standards are met. Curtis also serves as an alternate representative on the KCMCA (Kalamazoo County Medical Control Authority) Advisory Board, contributing to EMS Protocols, equipment management (AED & chest compression devices), and addressing EMS-related complaints. His role extends to technical rescue and hazmat team duties, along with coordinating monthly Community CPR classes.

Jesse Ogden, an integral member of Comstock Fire & Rescue since 2020, now serves as Lieutenant at Station 9-3. Transitioning to a full-time firefighter in 2021, Lt. Ogden plays a vital role in the department's operations. His responsibilities include EMS training and overseeing EMS Quality Assurance/Control in the records management system. Jesse's involvement as an alternate representative on the KCMCA (Kalamazoo County Medical Control Authority) Advisory Board further displays his commitment. As a Hazmat Team member and certified SCBA (Self-Contained Breathing Apparatus) technician, he contributes significantly to emergency response. Jesse is also actively engaged in Ambulance Contract monitoring and addressing EMS protocol-related complaints.

Michael Meulman, a valued member of Comstock Fire & Rescue since 2020, now serves as Lieutenant at Station 9-3. Having become a full-time firefighter in 2021, Lt. Meulman occupies a pivotal role within the department contributing significantly to various key responsibilities. As a Technical Rescue Team member, Lt. Meulman brings specialized expertise to emergencies. In addition to his role in technical rescue, he plays a crucial part in supporting the Deputy Chief with vehicle maintenance for department vehicles, demonstrating his commitment to ensuring operational readiness. Lt. Meulman is actively involved in training initiatives, particularly focused on best practices in vehicle extrication responses. He has actively contributed to the Ladder Truck committee, assisting in formulating specifications for the department's recently procured aerial truck.

Voters must select a party-specific ballot. Absentee voters will be mailed a selection form, in-person voters select the party on their applications to vote. Republican and Democratic parties participate in the Presidential Primary.



Proposal 2022-2 requires nine-days of early, in-person voting prior to State and Federal elections. The Presidential Primary will be the first election where early voting will take place in Kalamazoo County. Early voting begins February 17th.



Early voting will allow voters to insert their ballots into the tabulator but results will not be tabulated until election day.




If you vote early, you cannot retrieve your ballot once it's in the tabulator if your candidate drops out. If you vote absentee, you may spoil your ballot and request a new ballot.



If you're an absentee voter, you will need to select to be on the permanent ballot list on your party-selection form. The absent voter application will no longer be automatically sent after this election.



Michigan voters do not have to register with political parties but voters do have to request a party-specific ballot for the Presidential Primary. This does not bind you to a party for future elections.
