To comply with the Help America Vote Act (HAVA), voting instructions will be available in audio format and in Braille. The in-person location will have a voter assist terminal (VAT) available for voters with disabilities.

Absent voter ballots must be mailed to voters no later than 5:00 p.m. on Friday, November 3, 2023. Registered voters may contact their local Clerk to obtain an application for an absent voter ballot. On Election Day, voters may apply for, receive, and submit absent voter ballots in person from 7:00 a.m. to 8:00 p.m. at the locations below.
